

Casa Don Nacho Privacy Statement

Casa Don Nacho's policy is to comply with all applicable data protection and privacy laws. This commitment reflects the value we place on earning and maintaining the trust of our Employees, Customers, Business Partners, and Third Parties who share their personal information with us.

The Internet Privacy Policy describes how Casa Don Nacho protects your privacy when it collects personal information on its websites. The term "personal information" as used in this Policy means information that identifies you personally, either individually or in combination with other information we hold.

This Policy generally applies to all websites operated by Casa Don Nacho or on its behalf.

The purpose of Casa Don Nacho's website is to inform, present, and/or explain the services, approach, and purpose of Casa Don Nacho.

Your Authorization

By using Casa Don Nacho's website or providing us with personal information, you authorize us to collect, use, and disclose your personal information as described in this Policy and under the applicable website or country Privacy Statements.

If you do not authorize the collection, use, and disclosure of your personal information as described in this Policy (and following the applicable website or country Privacy Statements), do not use Casa Don Nacho's websites.

Collection, Use, and Disclosure of Personal Information

To the extent required by applicable laws, if we collect personal information through Casa Don Nacho's website, we will:

- Timely and appropriately notify you about our data practices.
- Only collect, use, disclose, and transfer such personal information with your authorization, which may be express or implied, depending on the sensitivity of your personal information, applicable legal requirements, and other factors.
- Collect your information only for specific and limited purposes. The information we collect will be important, adequate, and not excessive for the intended purposes.
- Process your personal information in a manner consistent with the purposes for which it was originally collected or for those you have subsequently authorized.
- Take commercially reasonable steps to ensure that your personal information is reliable for its intended use, accurate, complete, and, where necessary, kept up-to-date.

Information Collected Through Casa Don Nacho's Website and How It May Be Used

There are three ways we may collect information about you when you access and use a Casa Don Nacho website:

1. Information Sent to Us by Your Web Browser

Casa Don Nacho collects information automatically and sends it to us through your web browser. This information typically includes your Internet service provider's IP address, the name of your operating system (such as Macintosh® or Windows®), and the name and version of your browser (such as Explorer® or Netscape®). The information we receive depends on your browser settings. Please review your browser if you want to know what information it sends us or how you can change these settings. The information provided by your browser does not personally identify you. We use this information to create statistics that help us improve our sites and make them more compatible with the technology used by our Internet visitors.

2. Information Collected by Placing a "Cookie" on Your Computer

Casa Don Nacho may collect information about you by installing a “label” on your computer’s hard drive. This label is known as a “cookie.” Casa Don Nacho’s website uses “session cookies.” A session cookie is used to label your computer with a unique identifier generated by the computer when you access our sites. A session cookie does not personally identify you and expires when you close your browser. We use these session cookies to gather statistical information about how visitors use our sites, which pages they visit, which links they use, and how long they stay on each page. We analyze this information (known as “clickstream data”) statistically to better understand our visitors’ interests and needs and to improve the content and functionality of our sites. If you do not wish to receive cookies, you can configure your browser to reject them or notify you when a cookie is placed on your computer. While you are not required to accept cookies when visiting a Casa Don Nacho website, you may not be able to use the full functionality of the site if your browser rejects our cookies.

3. Information You Knowingly and Voluntarily Provide

Casa Don Nacho collects the information you knowingly and voluntarily provide when using a Casa Don Nacho website; for example, the information you provide when logging in to receive email alerts, responding to a survey, or when you inquire or sending us feedback via email. In many cases, this information will be personal. Casa Don Nacho uses this information for the reasons you gave it. For example, if you provide your email address when logging in to receive email alerts, we will use your address to send you the alerts you request. We also use the information collected through Casa Don Nacho’s websites for various business purposes, such as customer service, market research, product and service improvement, and to provide you and your company with information and offers that we believe may interest you. We may also remove all personally identifiable information and use the rest for historical, statistical, or scientific purposes.

Sharing Personal Information

Casa Don Nacho will not share the personal information collected through its websites with mass mailing list brokers without your express consent. Casa Don Nacho may share your personal information with other business units of Casa Don Nacho. When doing so, these other business units will use your information in a manner consistent with the purposes for which it was originally collected (or for the purposes you subsequently authorized) and only as described in this Policy and following applicable website or country Privacy Statements and other applicable data protection and privacy laws.

Casa Don Nacho may also share your personal information with third parties that we contract to provide support services. These third parties may only use the personal information we share with them to perform services on our behalf and are required to maintain its confidentiality. In some cases, Casa Don Nacho may share your personal information with third parties that partner with us to provide products and services to our customers. If we do so, we require these partners to use the personal information provided in a manner consistent with the purposes for which it was originally collected (or for the purposes you subsequently authorized) and only as described in this Policy and following applicable website or country Privacy Statements and other applicable data protection and privacy laws.

Personal Information Security

Your personal information will generally be stored in Casa Don Nacho’s databases or in databases maintained by our web service providers. Casa Don Nacho maintains reasonable safeguards to ensure the confidentiality, security, and integrity of your personal information.

Links to Third-Party Websites

Casa Don Nacho’s websites may contain links to third-party websites. These links are provided as a service and do not imply that we endorse the activities or content of these sites or any association with their operators. Casa Don Nacho does not control these websites and is not responsible for their content, security, or privacy. Please review the privacy policies included on these websites before using them or providing your personal information.

Retention of Personal Information

Casa Don Nacho retains the personal information collected through Casa Don Nacho's website as long as necessary to provide the services, products, and information requested by you or following the retention period specified by applicable laws.
